Services: Trainer agrees to provide private training lessons for Client and Dog on a lesson-by-lesson basis, the goal being to teach Client how to train and work with Dog. Lessons will take place at Client's home and/or other public locations. Trainer will make every reasonable effort to help Client achieve training and behavior modification goals but makes no guarantee of Dog's performance or behavior as a result of providing professional animal behavior consultation. Client understands that

he/she and members of the household must follow Trainer's instructions without modification, work with dog daily as recommended, and consistently reinforce training being given to Dog.

a. Client understands that in order for training to be effective over the long term it must be reinforced daily without deviation and by all members of the household. If Client does not follow instructions Client understands that Dog will revert to past behavioral norms through no failure or fault of Trainer.

Cancellation Policy: If Client fails to give at least 24 hours cancellation notice, or is not present at time of scheduled appointment, unless due to provable emergency or inclement weather, session fees are still due. For a package deal, the session missed will be deducted from the sessions left.

Liability: Trainer does not work with human aggressive dogs or dogs that have severely attacked another dog. If Dog causes property damage, bites or injures any dog, animal or person (including but not limited to Trainer and Trainer's agents), during or after the term of this Agreement, then Client agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Trainer and Trainer's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If Dog is injured in a fight or in any other manner during or after the term of the Agreement, Client assumes the risk and agrees that Trainer should not be held responsible for any resulting injuries, losses, damages, costs or expenses.

At Trainer's sole election, Trainer's duties shall terminate if (a) in Trainer's sole judgment Dog is dangerous or vicious to Trainer or any other person or animal, or interferes with the training of other dogs, or (b) Client breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Trainer's duties shall terminate but all other provisions of this Agreement shall continue in full force and effect.

This Agreement is binding upon Client, spouse of Client, children of Client and all household members and guests that may choose to be present during sessions and/or work with Dog at any time. This Agreement supersedes all prior discussions, representations, warranties and agreements of the parties, and expresses the entire agreement between Client and Trainer regarding the matters described above.

The undersigned also understand(s) that the degree to which Dog is successfully trained is a matter of the interest, commitment, and cooperation of Client. Accordingly, the undersigned acknowledge(s) and agree(s) that For P.E.T.S. LLC has not and will not make any promise, guarantee or warranty that their dog will achieve any particular level of training. This Agreement may be amended only by a written instrument signed by both Client and Trainer.
