With any changes, a new agreement will be presented before any new services are rendered.

## **Policies and Procedures**

The client agrees to the following:

## 1. <u>Liability Policies:</u>

- \* For P.E.T.S. agrees to provide services stated in this contract in a reliable and trustworthy manner. In consideration of these services and as an express condition thereof, the client expressly waives any and all claims against For P.E.T.S., unless arising from gross negligence on the part of For P.E.T.S.. Client agrees to notify For P.E.T.S. of any concerns within 24 hours of returning home or forfeit any right to redress.
- \* For P.E.T.S. shall not be held responsible for pets that bite, suffer an accidental death or escape from faulty fencing, gates or from inside the home due to faulty screens, doors, etc.
- \* For P.E.T.S. shall not be held responsible for any complications pets may suffer or actions of pets while they are unattended.
- \* For P.E.T.S. shall not be held responsible for the loss, injury, death, or actions of any house-pet that the client has let outside without supervision. For P.E.T.S. Will not allow house-pets outside while For P.E.T.S. is not there. This includes pets with dog doors and outdoor pets, with the exception of barn cats. For P.E.T.S. reserves the right to move an outdoor pet to shelter in the event of extreme temperatures/weather. For P.E.T.S. is not responsible for damages/costs involved with this move.
- \* The client understands that all pets (where appropriate) must have a veterinarian and must be up to date on the rabies vaccination. Client agrees to reimburse For P.E.T.S. for all costs (including, but not limited to, medical care and lost wages) associated with contracting any ailments while exposed to pet(s).
- \* All pets with electronic fences must wear their collars with fresh batteries. For P.E.T.S. is not responsible for any animals that get out or inside of perimeter.
- \* For P.E.T.S. will not sit for acutely ill animals or those with *uncontrolled* medical conditions. We suggest the pet be boarded with a vet in these circumstances.
- \* For P.E.T.S. does not accept aggressive animals. Client agrees to be responsible for all costs (including, but not limited to, medical care, attorney fees, etc) if client's pet should bite a person or animal.
- \* For P.E.T.S. will not walk unruly/untrained dogs or dogs that choke themselves on their leash. All pets must be walked on a leash, no exceptions. No extendable leashes. Training can be provided for additional fees.
- \* For P.E.T.S. does not diagnose, prognose, or make therapy decisions, nor does it offer veterinary services. Any veterinary/medical concerns will be referred to a veterinarian.
- \* Client authorizes For P.E.T.S. to obtain the services of a locksmith should a key/garage opener malfunction. Client is responsible for all charges.
- \* Client is responsible for making arrangements for snow/ice removal. Visits may not be made in snow/ice covered driveways and/or walkways because of safety concerns.
- \* Job sharing is not covered under our insurance. We can not be responsible for your pet or home if another service provider, friend or family member enters your property while we are not there.
- **2. Cancellation Policy:** Cancellations must be received no less than 24 hours of first scheduled visit or a cancellation fee of 50% will apply. For P.E.T.S. reserves the right to deny service or terminate service if job differs from original consult or if job poses safety concerns, financial concerns, or inappropriate or uncomfortable situations.
- <u>3. Business Hours:</u> Business and visiting hours fall between the hours of 7AM. And 9PM. and services are usually completed during this time unless we have agreed otherwise. For P.E.T.S. will not accept time specific calls as we can not guarantee specific times accurately.
- **4. Bad Check Policy:** A \$35 fee is assessed on all returned checks. All fees are due promptly and must be paid via money order or cash only.
- **5. Emergencies:** Client agrees to authorize For P.E.T.S. to handle any emergencies that may arise. For P.E.T.S. will make every effort to contact client, however, client gives For P.E.T.S. authority to act in the pet's/home's best interest and be available at an hourly rate of \$20. For P.E.T.S. requires you to have a responsible party to take care of your pet(s) in the event of unforeseen circumstances such as serious illness/injury and in the event of extreme weather or a natural disaster. It is best if your emergency contact is a neighbor so they can reach your home. For P.E.T.S. is not responsible for pets in these circumstances.
